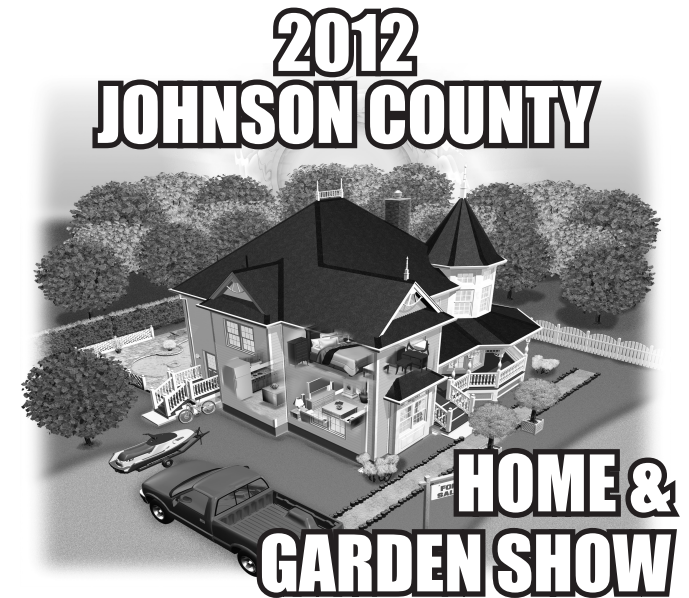

# The Event

• The 2012 Johnson County Home and Garden Show will be held at the Tecumseh Community Building on Friday, March 30, 2012 from 1:00 to 7:00 p.m., and on Saturday, March 31, 2012 from 9:00 a.m. to 1:00 p.m. Prize Drawings will be held on Friday Evening and Saturday afternoon.

• Booths for the event are 8 feet by 8 feet. Booths are draped and come with a 6 foot covered table and 2 chairs. Gym floor booths are \$100.00 each. Stage and Basement booths are \$75.00 each. A limited number of 10 foot by 10 foot outside booths are available for \$75.00 each. These booths are space only. The vendor will need to supply their own equipment. Sorry, but there will be no refunds on outside booths due to inclement weather. *\*All booth reservations are non-refundable before the event.*

• Gas powered equipment is welcome in your booth, as long as it does not have any fuel in it., Power items may be displayed and demonstrated outside of the building at your own risk.
