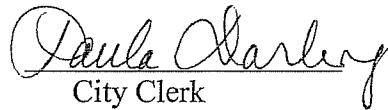
* Any item listed on the Consent Agenda may, by the request of any single Council member, be considered as a separate item under the Regular Agenda Section of the Agenda.

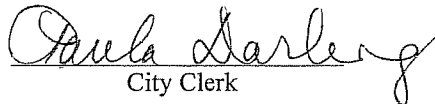
The Mayor and City Council reserve the right to adjourn into Closed Session for the protection of the public interest at any time.
