Review and consider introduction and adoption of Ordinance # 12-1049 an Ordinance of the City of Tecumseh, Nebraska allowing inclusion of the following tract of land into the City of Tecumseh, Nebraska; Part of the Southeast Quarter of the Southwest Quarter of Section 22, Township 5 North, Range 11 East of the 6th P.M., Nemaha County, Nebraska, being more particularly described as follows: Considering the East line of the SW ¼ of said Section 22 as bearing N00°21'33"W and with all bearings contained herein relative thereto: Commencing at the S 1/4 Corner of said Section 22, thence northerly along the said East line of the SW ¼ N00°21'33"W 54.5 feet to a point on the North right-of-way line of Nebraska Highway #136, said point being the True Point of Beginning; thence westerly along the said North right-of-way line N86°39'43"W 570.17 feet to a point; thence continuing westerly along said the said North right-of-way line S86°39'40"W 151.2 feet to a point; thence leaving said right-of-way line and continuing northerly parallel to the said East line of the SW ¼ N00°21'33"W 171.10 feet to a point; thence continuing easterly N90°00'00"E 720.0 feet to a point on the said East line of the SW1/4; thence southerly along the said East line S00°21'33"E 195.5 feet to the True Point of Beginning.

This notice will be posted in three public places in the City and members of the City Council will simultaneously be served with a copy of this notice.


The Mayor and City Council reserve the right to adjourn into Closed Session for the protection of the public interest at any time.
